In order to enhance the overall safety and efficiency of the fair, new measures have been implemented. Please pay attention to the summary as follows. For details, please refer to section 4 of the Exhibitors' Manual.

	of HK\$3,000 (US\$400) will be charged to the Exhibitor or its appointed contractor.

	doubled. Minimum and maximum deposit amounts are HK\$5,000 (US\$667) and HK\$75,000 (US\$10,000)
	respectively.

4.2.3	Contractors are required to carry out and maintain <u>public liability insurance</u> in respect of the contractor's liability
	for death or injury to any persons, or loss or damage to property arising out of the performance of the Services in a
	sum not less than HK\$10 million for any single claim, unlimited in aggregate. In addition, contractors are
	required to comply with Section 40 of the Employees' Compensation Ordinance, Cap.282 ("ECO") to cover their
	liabilities both under the ECO and at common law for injuries at work in respect of all their employees, irrespective
	of the length of employment contract or working hours, full time or part time, permanent or temporary employment.
	A contractor should also carry out and maintain valid and adequate insurance against theft, fire, damage to
	property, accidents, natural calamities, acts of God and such other risks normally insured against by a reasonable
	person in the position of the contractor, or as the Organiser may require, in connection with, inter alia, contractor's
	property (including all equipment, fittings, furniture, materials and other facilities used or provided by the contractor
	in the performance of the Services) and the performance of the Services.
	The insurance should be maintained in force at all times during move-in period, exhibition period and move-out
	period, i.e. 25 Feb – 3 Mar 2024.
